### Directions to the site:

Common directions from Route 202 Southbound:

- Approximately two miles down Route 202, you will travel under a train overpass. Make a right at the next turn onto Milltown Road. Travel a half mile, and North Branch Park will be on the left.

From Route 287 Southbound:

- Follow Route 287 South to Exit 17 (Somerville/Rte. 202/206 South). When the highways split, take Route 202 South. (Follow common directions above)

From Route 287 Northbound:

- Follow Route 287 North to Route 22 West to Route 202/206 South. After a half mile, the highways split. Take Route 202 South. (Follow common directions above)

From I-78 Westbound:

- Follow Route 78 West to Route 287 South to Exit 17 (Somerville/Rte. 202/206 South). When the highways split, take Route 202 South. (Follow common directions above)

From I-78 Eastbound:

- Follow Route 78 East to Route 22 East. Follow Route 22 East through Branchburg. Make a right turn onto Milltown Road. Follow Milltown Road for 1 mile and bear right under the railroad trestle. North Branch Park will be on the right.

**Test Qualifiers (Junior & Qualified Courser) Dark Green Ribbon**

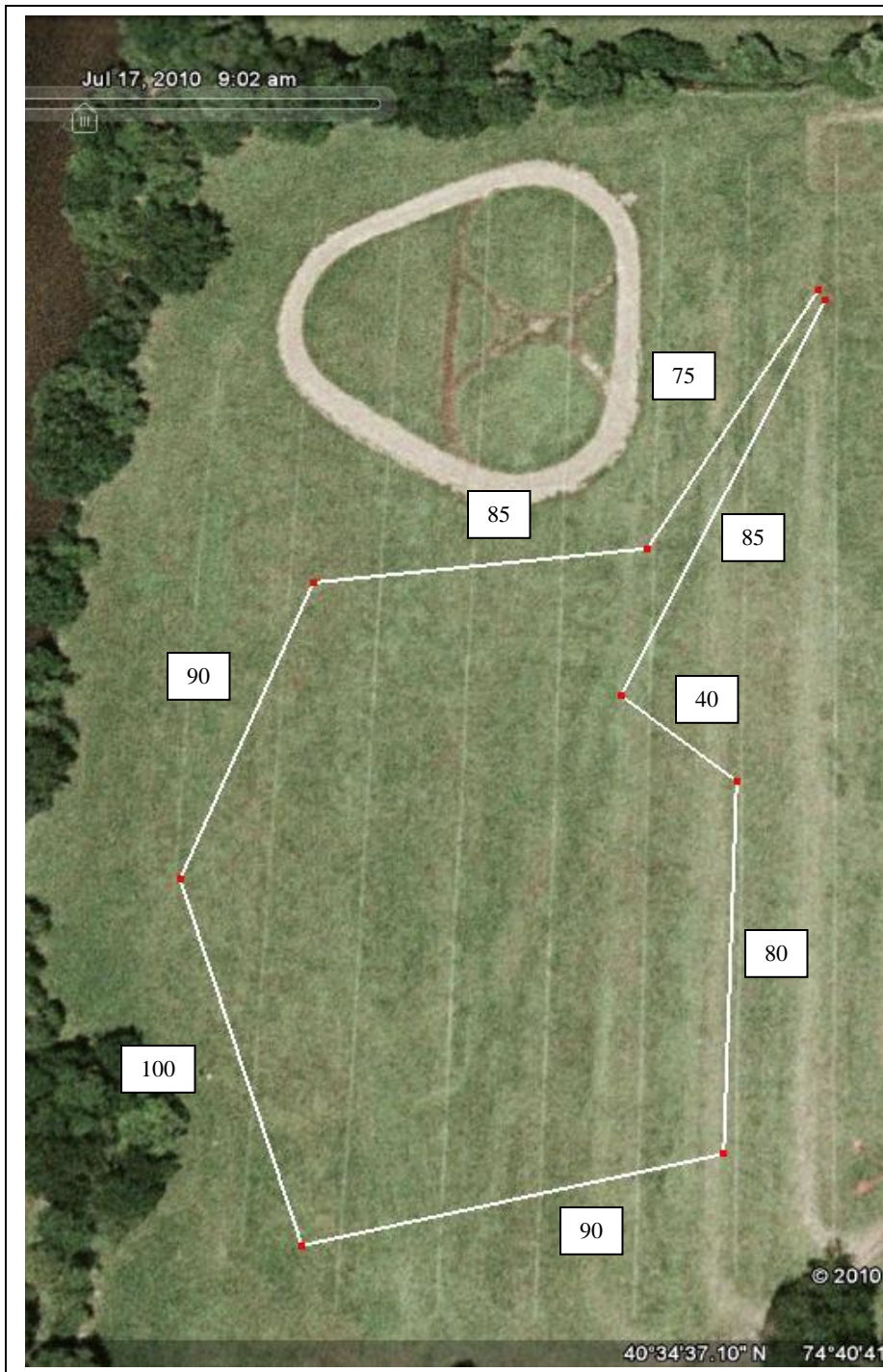
**QUALIFIED COURSER:.** Open to hounds at least 12 months of age. A hound must run the course with a hound of its own breed or one of similar running style and must complete the entire course with enthusiasm and without interruption. The course is a minimum of 600 yards with a minimum of four (4) turns.

**JUNIOR COURSER:** Open to all eligible sighthounds at least 12 months of age. A hound running alone must receive a certification from a Judge on one date, and a second certification from a different Judge at a later date, with each Judge stating that the hound completed a (minimum) 600-yard course with a minimum of 4 turns. The hound must complete the entire course with enthusiasm and without interruption. Ribbons (Dark Green) will be awarded to all hounds that successfully complete the AKC Junior Courser Test.

**NOTICE TO EXHIBITORS:** Bitches in season and lame hounds will be excused. Hounds not present at time of Roll Call will be scratched after a 5 minute grace period. Each entry will be examined at inspection for breed disqualifications. Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic bags or strips. Backup equipment will be available. The course will be reversed for the second JC test. The members of GVFRRC reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
