From the North: RT 78W to 287 S to Somerville 206S, follow directions below from Somerville .

From Somerville: Rt 206S 5.6 miles to 2nd light after McDonalds. Turn right onto Rt 514-Amwell Rd. Continue on Amwell Rd. – Rt 514 4.5 miles to 3 way stop at stone church. Go straight, second left is Wertsville Road. Follow to first stop sign, turn left, make first right to continue to Wertsville. Country Club entrance 2 miles on right.

From Trenton: Rt. 31 N to 202 N. First exit is Wertsville Rd. Make right on Wertsville HCC is 6.5 miles on left

Eligible Breeds and Registry

Only purebred Afghans, Basenjis, Borzoi, Greyhounds, Ibizian Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Sloughis, Scottish Deerhounds and Whippets, one year of age or older and who are registered with the American Kennel Club or an AKC recognized foreign registry or have an Indefinite Listing Privilege (ILP), are eligible for an entry. Breed disqualifications apply.

Stakes Offered

JUNIOR COURSER: Open to all eligible sighthounds. A hound running alone shall receive a certification from a judge on one date, and a second certification from a different Judge at a later date, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption.

OPEN STAKE: Any eligible sighthound that is an AKC Field Champion, or an AKC Junior Courser Suffix (JC).

SPECIALS STAKE: Any AKC Field Champion of Record

OPEN VETERAN STAKE: Open to any hound that is qualified to enter AKC lure trials. In addition, the hound must be at least 7 years of age on the day of the trial, except Borzoi, Greyhounds, and Scottish Deerhounds who must be at least 6 years of age, and Irish Wolfhounds, who must be at least 5 years of age. Championship points will be awarded.

Best in Field Will Be Offered Both Days (Italian Greyhounds are NOT eligible)

NOTICE TO EXHIBITORS: All Hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at time of Roll Call will be scratched after a 5 minute grace period. Each entry will be examined at inspection for breed disqualifications. Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic bags or strips. Backup equipment will be available. The course will be reversed for the final courses. The members of GVFRRC reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial.

THERE WILL BE A \$5 FINE ASSESSED FOR ANY LOOSE HOUND WHICH INTERRUPTS A COURSE IN PROGRESS.

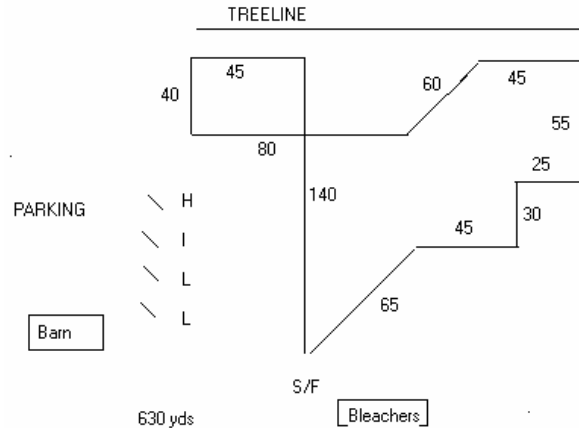

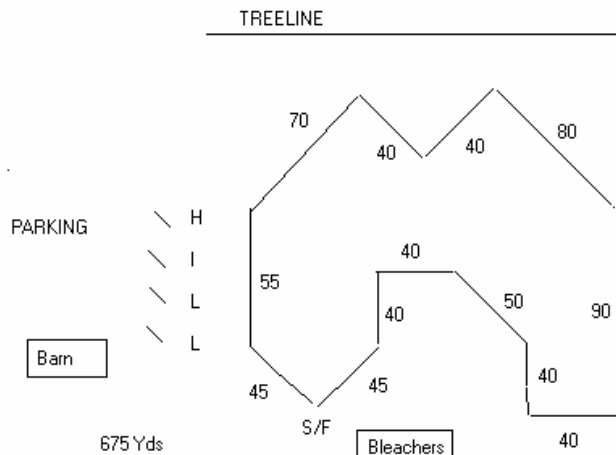
